**EXECUTIVE DIRECTORS REPORT-** Evening and day-time service trips for December 2023 totaled 13,890. An increase of 1,890 trips from December 2022. BTA is up 6,942 trips in the first six months of FY 2023-2024 for local service.

Commuter service total trips were 1,035 for December 2023. An increase of 88 trips from December 2022. BTA is up 1,335 trips in the first six months of FY 2023-2024 for local service.

BTA was notified this week by FTA that BTA's Triennial Review is this year. The letter stated that the requested paperwork is due February 29, 2024. BTA staff are already preparing for the review- staff will be conducting a meeting this week to designate who will be addressing which areas of the review. John also has a new contact with FTA Region 3 and he will be speaking with the new contact tomorrow. This will be BTA's second FTA Triennial Review.

The Butler County Commissioners are to reappoint Charles Savannah and appoint a new BTA Board Member by the end of January 2024.

The next regular scheduled board meeting is Tuesday February 13, 2024 at 5:00pm at the BTA Transit Center Board room at 130 Hollywood Drive.
